- ISO Fire Inspection is due for January 2019. Performed once every 10 years. Current score rate for Haw River is a "5" for Inside Town and a "5" Outside of Town. Scores range from 1 (excellent) to 10 (poor).

- Lang St Pump station still in process and state will approve delay.
- New Pumps due to arrive late Dec and installation will be for both in Jan 2019.
- Still waiting to hear on final route from MVP Southgate Project.
- Master sidewalk plan is complete, but we are waiting for reimbursement for both payments.
- Public Utilities Grant should be funded in January 2019 for both Water & Sewer. Should get updated by end of Jan or Feb 2019.
