Manager's Reports

- 1. Lang Street Pump Station Possible UDSA loan with 2-3 % interest with financing up to 40 years. Possible 45% grant involved due to low poverty level on that census tract. Town staff and AWCK are starting to work with USDA on this. **On-going**
- 2. PTRCG Town staff has sent Town Council all documents regarding the new personnel manual. This includes the employee handbook, the personnel manual, and the policy and procedure manual. When will Town Council be ready to bring it forward? Town Council decided to hear it at the August meeting date. On-going
- 3. The Town is still investigating the I & I from the Hanover Road outfall. Gavel and Dorn has removed the sewer meters, and we are waiting on a final report to see what is going on. **Ongoing**
- 4. The Town will be hosting the painting of the mural (side of the museum) on Saturday, July 24th

from 10 am - 3 pm. On-going

- 5. The rezoning on Trollingwood Road (parcel id# 152828) (next to Nova-Flex) was tabled by the Haw River Planning Board until the next meeting on July 26th. **On-going**
- Repaving of Main Street NCDOT is planning to pave East and West Main Street from North Church Street to Highway 70 within the next few weeks. On-going
- 7. Police National Night Out will be on August 3rd from 6 pm to 8 pm. Details to follow. Location TBD. **On-going**
- 8. Street Concert for September 2021? Any interest in this? Band? Food?
- 9. Charlie Davis reported on property liens and collections via Alamance County.
