# **Public Hearing**

1. Town Council to consider request from Town Staff to amend the Zoning Ordinance on sections 155.006, 155.070, 155.073 Temporary Events & 155.086 "Required Conditions for Special Use Permits". Items discussed included a temporary event application, insurance waiver, security plan, and setting the permit fee at \$100.00

### **New Business**

- 1. Request from Town Staff to amend the Town Code of Ordinances (Zoning Ordinance) on sections 155.006, 155.070, 155.073 Temporary Events & 155.086 "Required Conditions for Special Use Permits".

- 2. Town Council to approve or not approve the "Consistency Statement" to adopt the Zoning Ordinance changes.
  - Motion made by Council Member Kelly Allen to approve the consistency statement as presented, and that the text amendments are consistent and reasonable with all of the Town's adopted plans. All in favor 3 0
- 3. Council will consider a donation from Honda Power and Equipment of a Honda EG2800i generator as a thank you to all community partners. Approx. \$3,000 value.
  - Motion made by Council Member Steve Lineberry. All in favor 3 0

4. Town Council will have a discussion regarding the landscape agreement with N.C. Railroad along the right of way at Graham Road & Highway 49 (Main Street. NCDOT stated that it will take 3 to 4 weeks to see some mowing & trimming along the R/W. Hopefully by Thanksgiving to trim some trees down. The Town does have a landscape contract with N.C.R.R. to do some landscaping within the NCRR right-of-way. Town Manager Tencer asked for this to be tabled until all Town Council are present to discuss.
